# F&B Minimums



When booking an event in The Venue at Gaslight Co. or The Backroom Speakeasy, there may be a minimum food and beverage spend required

## ✓ What does it mean?

- The F&B minimum spend is the amount your group commits to spending on food and drinks during your event. This is required for celebrations including but not limited to: Birthday Parties, Wedding Receptions, Bridal Showers, Company Mixers, Holiday Parties, etc.
- The food & beverage minimum spend is determined by date of event, time and number of guests.
- Rental fees are separate and do not count toward the minimum spend.

## ✓ What's Included?

Your minimum spend can be used toward:

- Customized food menus (appetizers, buffets, grazing tables, desserts)
- Signature cocktails, wine, beer, and full bar selections
- Have guests purchase drinks toward the minimum, host a select number of drink tickets, or host the bar until the minimum is met

# Venue Policies

**Catering:** Gaslight Co. offers a menu of house-made spreads and heavy apps ideal for celebrations and gatherings.

- Outside catering is permitted for an additional fee.
- All outside caterers must be licensed and insured, and provide staff for setup, service, and cleanup.

**Alcohol and Beverages:**

As a fully licensed craft bar and kitchen, all alcoholic beverages must be provided and served by Gaslight Co. No outside alcohol or bar services are permitted.

Bar Service Includes:

- A full selection of craft cocktails, beer, wine, and non-alcoholic options.
- Professional craft bartenders
- Customizable drink menus and hosted or cash bar options available.

We do not allow BYOB or outside alcohol vendors under any circumstances, in compliance with our licensing. Any violation of this policy may result in early termination of bar services.

Our professional bartenders are trained to ensure all guests have a safe and enjoyable experience. As part of that commitment, we reserve the right to refuse service to any guest who appears intoxicated or is acting inappropriately.

**Vendor Policy:** We understand that each event is unique, and we welcome clients to bring in their preferred vendors to make the day truly personal.

Outside Vendors:

- Clients are welcome to use their own vendors for services such as photography, florals, entertainment, and décor.
- All outside vendors must provide proof of insurance and sign our vendor agreement at least 10 days prior to the event.
- Vendors are responsible for setup and breakdown within the rental window unless additional time is arranged in advance.

**Decorations and Alterations:**

You're welcome to decorate the venues to suit your event theme, but please consult with our team for approval of major decorations or alterations. Any decorations must be non-destructive and removed at the end of the event. Glitter is not permitted, ask our team about alternatives.

**Capacity Limits:**

The maximum occupancy for the venue must be strictly adhered to for safety reasons. The Venue can hold up to 80, The Backroom Speakeasy can hold up to 50 and when rented together, both spaces can hold up to 115 people.


**Damages and Liability:**
